JUNE 30, 2002 Report shows violation of 21-5-33 -> use of campaign money to pay for SUV, vehicle expense of \$1060.68 each month. This elected official serves as Chairman of Appropriations but violates Georgia Ethics in Government Act. His actions are reprehensible.*
